## **New Business:**

- A. Mini Grants: Dick Wedin stated that the mini grant process was dropped a few years ago because there wasn't enough money or interest. Dick suggested the foundation reinstate the mini grant program without any dates or deadlines so teachers can apply when they need the funds. Dick reviewed the mini grant section of the website and edited the deadline section. Bob Titus stated that since the mini grant program is an existing program we don't need to review the changes on the website. Dick Wedin made a motion to reinstate the mini grant program without specific dates and times for application. Bob Titus seconded. The mini grant program was approved to be reinstated with a removal of the date and time requirements.
- B. School District Participation in the ESDEF: Discussion occurred about having representation from the Ellensburg School District. Bob Titus reviewed the discussion that incurred at the June meeting with Paul Farris and the importance of getting feedback from administration for our ideas, projects or concerns before approaching schools. Paul was supportive of our request and was committed to being a part of this foundation. The group discussed having the school principals attend our meeting to have an interactive discussion about the foundation and about the needs of schools in the district. Dick suggested we invite a principal to our next meeting. David Bowen agreed to meet with Paul Ferris to let him know that we will be corresponding with the principals and the school board. He also agreed to send letters to the school principals and school board members.

- A. **Scholarship Night**: no update. Discussion incurred about the previous meeting where Mary Gordon agreed to speak with Mr. Ellersik about Scholarship Night. An update is expected at the next meeting.
- B. **Grant Writer**: Discussion incurred about having a grant writer and grant writing in general. Cathy Bambrick will invite Margret to the next meeting to have a general conversation about grant writing processes.
