Superintendent's report (Mike Nollan)

- Interesting start to the new year (smoke delay), still figuring out how to make that up
- Air quality now good
- Teachers/classified staff back Tuesday. Positive welcome back for staff.
- Morgan open; working well. Still in process 9 months to completion. Finishing first phase. Auditorium, gym, classrooms good.
- Kindness initiative projects throughout district. Based on the book *Wonder* by RJ Palacio. Whole-school read for many schools. Community wide kindness theme.
- Superintendent search underway. Developing criteria in preparation for posting position. Community forums in January. Goal, July 1 start date.
- Levy in February still TBD based upon legislature.
- Facilities: survey out by next week. 2019 bond for managing elementary school overcrowding.
- Enrollment high 560-600 at Valley View. 400 desirable. Classrooms approaching 30.

School board elections upcoming with one position to fill.
