Mary reports requests have slowed down. She has some ideas she will develop this summer and asked Mike to put it on the retreat agenda. She has streamlined the communication process with school counselors and administrators and received a generous donation from WESCU (Washington State Employees Credit Union).

Old Business

- Following discussions and new funding developments, Jason Eng's \$2,000 minigrant to support the Robotics club reverts to its original intent to support registration and extra kits.
- Mike will forward a questionnaire sent by the website graphic designer.
- The ESDEF board met with the school board June 1 to report on projects and goals.
 Dan extended the school board's thanks for the presentation and for the foundations
 efforts at catching projects that would otherwise fall through the cracks, especially
 with the cuts to the current levy. Lowell requested the levy cuts be addressed at the
 summer retreat and that a comprehensive plan including possible grant writing be
 developed.
- Planning for the Kittitas County Youth Awards is moving forward, with approximately 18 people involved. The deadline for nominations is the first week in January; the awards will be distributed March 4 at the Morgan Middle School auditorium. There will be 7-8 categories and each nominee will receive a certificate.
- New logo design: Mary passed around current publications (brochure, stationery).
 She is working with graphic designer Andrea Pasco on developing a new logo. It was agreed to maintain the name "Ellensburg School District Education Foundation." There was discussion about the graphic content of the logo. Mary suggested board members go online to look at other education foundation logos and bring ideas to the retreat.
